1. Grant of Rights

2. Description of Media

3. Model's Representations and Warranties

The Model represents and warrants that they are at least 18 years of age or have obtained necessary parental or guardian consent if a minor, possess full legal capacity to enter into this Agreement, and that the consent of no other person or entity is required to grant the rights herein. The Model agrees that no further compensation or approval is required beyond what is set forth in this Agreement.

4. Release and Waiver

The Model releases and discharges the Photographer/Producer from any claims, demands, or causes of action that the Model may have now or in the future arising out of the use of the media, including but not limited to claims for defamation, invasion of privacy, or infringement of moral rights.

5. Compensation

The Model acknowledges receipt of good and valuable consideration, the sufficiency of which is hereby acknowledged, and agrees that this release is binding without regard to any further compensation or agreement unless otherwise

specified in a separate written contract.

6. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law principles. Any disputes arising under or related to this Agreement shall be subject to the exclusive jurisdiction of the state and federal courts located in _____ County, _____.

7. Entire Agreement

This document constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior agreements, understandings, and negotiations. Any amendments must be in writing and signed by both parties.
